#### INTRODUCTION

The Siang District is newly created district bifurcated from greater East Siang District during 2015. The headquarter of Siang District is Pangin. Since it is a new District the department of Fisheries has no office and accommodation of DFDO. Till today only DFDO is posted in Siang District without a single Staff.

The Siang District is endowed with the natural water bodies Say Rivers like Siang, Simang, Rabung, Ribung, Nerbung, Nyupbung, Subbung, Rubung Hirit, Siyom, Sipeng, Lorbung, Jabung, Gebung, Ehi, Jahing etc. There are many potential streams and lakes available in the Siang District: The main source of livelihood of the people of Siang district is paddy cultivation. So the area is best suited for taking up paddy —cum — Fish culture. There are numerous rivers and stream which feed paddy cultivation in the Siang District.

The Fisheries activities in the Siang are found to be very remote. The people are not aware of Fisheries importance. The department needs to focus on imparting Fisheries training programme in circle wise/Block wise/Village wise. The promotion of Fisheries is very urgent in this untouched newly created Siang District. Geographically the Siang District is very vast with unique landscape. The upper hilly region is very cold and the foothill areas are warm.
