Of late, it has been noticed that most departments are not following the procedure laid-down in the Govt. order of even number dated 9/4/87 read with order dated 29/7/91 regarding the procedure for grant expenditure sanction of the regarding the procedure for grant expenditure sanction of the Non-plan and plan schemes of the State Govt. It is reiterated Non-plan and plan schemes of the State Govt. It is reiterated that the following existing procedure as laid down in the above referred orders need to the followed by all Departments scrupulously.

- (i) Secretary of the concerned Department may accord expenditure sanction upto Rs. 15.00 lakhs.
- (ii) The concerned Departmental Ministers may accord expenditure sanction to the schemes costing upto Rs. 50.00 lakhs.
- (iii) The cases of sanction exceeding Rs. 50.00 lakhs shall be submitted to the Committee for approval. The Cabinet Committee will consist of:
 - (a) Chief Minister Chairman
 - (b) Finance Minister Member
 - (c) Minister-in-charge Member. of the Deptt.

Department. Most Departments sent their proposals for approval to the Cabinet Sub-Committee without obtaining prior concurrence of the Finance of the Finance Department. Any proposal requiring Cabinet Sub-Committee concurrence must repeat must have the prior concurrence of FD before it is to be put up before the Members of the Cabinet Sub-Committee. Commissioner/Secretary of the deptt. must ensure that no proposals are put up to the Cabinet Sub-Committee without the prior concurrence of the FD. In case any proposal has already gone to Cabinet Sub-Committee without prior concurrence of FD, the Commissioner/Secretary of of the concerned Deptt. may like to withdraw the proposal so as to obtain prior concurrence of Finance before the matter is considered by the Cabinet Sub-Committee.

Also it has been observed that the Departments do not submit their schemes/proposals included in AOP in time to Finance Deptt. for concurrence and tend to rush the files at a very late stage in the financial year. The late submission of files not only hamper proper and timely implementation of the schemes but also put the finance deptt. under unnecessary pressure of work at the end of the year.

To overcome the difficulties and also for smooth clearance of plan schemes/proposals files, it has been decided that Finance Deptt. would accept such files only upto 20th March 99 repeat 20th March 99.

All Departments are therefore, requested to submit their proposals within the time limit as mentioned above.

The above instruction must be scrupulously followed.
