

Notification No. PR-106/7 (Pt-A) (B) Dated 22<sup>nd</sup> October'2008 issued in pursuance of Article 243-G of the Constitution of India read with Section 30, 70, 93 of the Arunachal Pradesh Panchayati Raj Act, 1997 regarding Devolution of Powers to the three tiers of Panchayati Raj Institutions (PRIs) namely, Zilla Parishad, Anchal Samiti and Gram Panchayats, the Governor of Arunachal Pradesh is pleased to order that the offices of the DRDAs and Block Development Officers along with the staff and Officers are placed under the administrative control of the respective Zilla Parishads. All the CSS schemes and programmes hitherto implemented by the above offices shall henceforth be implemented by the Zilla Parishads. The salary and establishment cost of the above offices shall continue to be borne by the Govt.

The services and establishment matters of the above staff and officers shall remain under the control of the concerned cadre controlling authority.


