ORDER

In order to avoid delay in execution of projects / schemes and timely release of CSS / state funding schemes / projects, the following instructions with respect to geo-tagging of projects shall be followed by all the departments with immediate effect:

- (i) Single File System shall be followed, i.e.
 - a. for the purpose of issue of Lines of Credit (LoC) / Expenditure Authorization / Utilization Certificate, the concerned Chief Engineer / Director / Equivalent Officer of the project / scheme shall submit the file to the concerned Principal Secretary / Commissioner / Secretary in a file;
 - b. such concerned Principal Secretary / Commissioner / Secretary shall record his/her observations / comments in the same file, and send file to:
 - i. the Finance Department / Planning Department / Line Ministry of Government of India, as the case may be, if he / she agrees with the proposal; or
 - ii. the concerned Chief Engineer / Director / Equivalent Officer of the project / scheme for compliance of the observations / comments.
- (ii) Concerned Principal Secretary / Commissioner / Secretary shall ensure that the requisite information and formats are duly filled up properly and the checklist provided to the Finance Department is complete in all manners;
- (iii) Concerned Chief Engineer / Director shall ensure that geo-coordinates of project site of each project / DPR shall be geo-tagged on Arunachal Monitoring Application before submitting the file to the concerned Principal Secretary / Commissioner / Secretary and a declaration to this effect shall be recorded by such concerned Chief Engineer / Director on the same file notings;
- (iv) Concerned Chief Engineer / Director shall ensure that physical progress and financial progress of the project / scheme shall be uploaded on the Arunachal Monitoring Application before submitting the file to the concerned Principal Secretary / Commissioner / Secretary for Administrative Approval and Expenditure Sanction / release of funds / LoC Authorization, and a declaration to this effect shall be recorded by such concerned Chief Engineer / Director on the same file notings;

In case, if it is found on scrutiny that such declaration w.r.t. geo-tagging of the project site (i.e. either it is not geo-tagged or not properly tagged) or declaration w.r.t. physical progress and financial progress of the project / scheme, made by the concerned Chief Engineer / Director is false / not correct, then disciplinary action shall

be initiated against such concerned Chief Engineer / Director of the project along with other concerned officers / officials;


- (vi) Finance Department and / or Planning Department, as the case may be, shall ensure that such declarations w.r.t. geo-tagging of the project site and physical & financial progress of the project / scheme given by the concerned Chief Engineer / Director are available on the same file, in absence of which such file shall not be accepted by these Departments, and failure to do so shall invite disciplinary action against officers / officials of Finance Department and / or Planning Department, as the case may be;
- (vii) Finance Department and / or Planning Department, as the case may be, shall consider such declarations w.r.t. geo-tagging of the project site and physical & financial progress of the project / scheme given by the concerned Chief Engineer / Director as an Authentic Document, on the basis of which, Finance Department and / or Planning Department shall process the same file for expenditure sanction / release of funds / issue of LoC, etc. and send the file to the same officer of the concerned Department from whom the file was received, if Finance Department and / or Planning Department, as the case may be, agrees with the proposal;
- (viii) In case, the Finance Department and / or Planning Department, as the case may be, has any query(s), such query(s) shall be raised on the same file within days in one-go (i.e. at once and not in bits and pieces) and the file be returned to the same officer of the concerned Department from whom the file was received for clarification of the same.
- (ix) In case of any query(s) raised by the Finance Department and / or Planning Department, as the case may be, the concerned Chief Engineer / Director shall submit clarification of the same to the Finance Department and / or Planning Department, as the case may be, through concerned Principal Secretary / Commissioner / Secretary within 7 days, and the process mentioned in (vi) and (vii) above shall follow;
- (x) In case, if it is found on scrutiny that the Finance Department and / or Planning Department, as the case may be, has raised frivolous query(s) or the concerned Chief Engineer / Director does not provides proper clarification to such query within prescribed time limit, leading to delay in the project / scheme, then disciplinary action against officers / officials of Finance Department and / or Planning Department and / or concerned Chief Engineer / Director, as the case may be, shall be initiated;
- (xi) Progress on the Arunachal Monitoring Application shall be updated every quarter by the field engineers which will be monitored by Chief Engineer / Director of the department
- (xii) Finance Department / Planning Department, as the case may be, shall separately undertake random check of at least 20% cases received in the Finance Department / Planning Department, as the case may be, in this regard, and any discrepancy found during such random check shall be brought into the notice of the concerned Principal Secretary / Commissioner / Secretary by Finance Department / Planning Department,

as the case may be, within 7 days of the date of random check for taking appropriate action;

(xiii) MIS data and report shall be submitted to the Office of Chief Secretary on monthly basis by Monitoring Division of Planning Department;

(xiv) A Special Cell comprising of officials of SRSAC, Finance and Planning Departments shall be created to monitor the progress of projects / schemes.

3. Henceforth, every Project under Centrally Sponsored and State funded such as SADA, SIDF, NESIDS, RIDF, UNTIED, MLALAD, MPLADS, NEC, BADP etc. implemented by the Departments must be Geo-tagged by the Departments using the portal

4. Accordingly, all the Head of Departments are directed to instruct their field functionaries to carry out the mandatory Geo-tagging exercises on all the projects executed by them in year wise, District wise and scheme wise through Arunachal Monitoring web portal.
