





Aggrieved by the govt. order No FISH/E(TP)45 dtd.05-10-2015, Shri Marngu Kadu, DFDO Pasight has filed a WP No. 470(AP)/2015 against his transfer / Posting as Asstt. Director Fisheries (Trg) Emchi, FFTC, Papum pare district in the Hon'ble Gauhati High Court Itanagar permanent bench, Naharlagun. The Govt. order is at F-'A' and the WP is at F-'B'. Admitting the petition the court has passed order dated 16/10/2015 directing to maintain status quo till disposal of the representation to be submitted by Shri M.Kadu, DFDO to any of the appropriate authorities for disposal within 5 (five) days from the date of the order. Copy of the order is at P-(57-75) .

2. In the mean time, Shri Obuk Mize, DFDO Asstt. Director Fisheries, Emchi, FFTC Papumpare in pursuance of the impugned govt. order joined in the establishment of Deputy Commissioner, Pasighat on 08/10/2015 while Shri M. Kadu, DFDO Pasighat was on 5 days casual leave as sanctioned by DC Pasighat and before he resumed office, Shri Obuk Mize, took over charges of DFDO Pasighat ex-parte on 19/10/2015.

3. In the mean time, in pursuance of order dated 16/10/2015 of the Hon'ble High Court, Shri M.Kadu, DFDO submitted his representation dated 17/10/2015 in the office of Commissioner (Fisheries) Itanagar on 17/10/2015 while the regular Commissioner (Fisheries) was out of station in Bihar performing election duties as General observer as per ECI order No. 464/OBS/2015/EMS dated 29/09/2015. Unfortunately, the link officer did not accept the representation and the representation remained without disposal leading to the present contempt proceedings against the three officers.

4. On expiry of the stipulated 5(five) days time, Shri M.Kadu filed contempt petition which was admitted and the court passed order dated 04/11/2015 directing to initiate contempt proceedings against three officers, that is regular Commissioner (Fisheries), DC Pasighat and Shri Obuk Mize, DFDO. The contempt notice is at P-(53-56). The Para wise replies to the contempt petition are being submitted to the court for consideration.

5. On receipt of the court order the DC Pasighat has passed an order dated 19/10/2015 directing inter-alia that Shri M.Kadu, DFDO will not be released from Pasighat till disposal of his representation. Copy of order of DC Pasighat is at P-77C.

6. On examination of the representation of Shri M. Kadu. DFDO it has been seen that he has requested to retain him at Pasighat as DFDO till April-May/2016 on the following grounds.

**Sub: Proposal for reviewing Transfer/Posting of DFDOs.**

The Department is in receipt of a Court contempt Order No.34(AP) 2015 Dated 04-11-2015 in WP(C) No.470(AP)/2015 dated 16-10-2015 filed by Sri Marngu Kadu, DFDO, Vs State of Arunachal Pradesh for not disposing of his representation dated 17-10-2015 at P/63-65C in which the Hon'ble High Court was directed for disposing his case within one week period and for maintaining status quo as on 16-10-2015 till disposal of the representation of Sri Marngu Kadu without fail for retention of Sri Kadu as DFDO, Pasighat as per norms procedure and guidelines on transfer and posting. The contempt notice may please refer at P/53-56C and detail judgment at P/ 57- 75<sup>C</sup>.

Due to regular Commissioner (Fisheries) was on requisitioned to Bihar Election duties the representation of the above said petitioner Sri Marngu Kadu could not be disposed of till date. And though we have applied for extension of time period for 2(two) months a notice of court contempt No.34(AP)/2015 has been received in the personal name of Commissioner (Fisheries), Deputy Commissioner, Pasighat and Sri Obuk Mize, DFDO.

Therefore, it is propose to obtain government decision and approval to dispose of the representation submitted by Sri Marngu Kadu, DFDO. And apart from above we are also in receipt of retention application up to April-May/2015 at their respective places of posting from Sri Ige Tacha, DFDO, Aalo at P/78C & Sri Kenbom Chisi, DFDO, Yingkiong at P/79-82C, are also require for decision.

Hence propose for obtaining Government approval and decision for the above representations submitted by the DFDOs, please.

ORDER

Whereas aggrieved by the government order No.Fish/E(TP)458/2013 dated 5<sup>th</sup> October'2015 against his transfer from Pasighat to FFTC, Emchi, Papumpare district as Assistant Director of Fisheries(Trg), Shri Marngu Kadu, DFDO Pasighat, East Siang district filed a Writ Petition No.470(AP)/2015 dated 16/10/2015 in the Hon'ble High Court, Guwahati, Itanagar Permanent bench, Naharlagun;

And whereas, admitting the WP No.470(AP)2015 the Hon'ble High Court passed an order dated 16/10/2015 directing the parties to maintain status quo and also directed Shri Marngu Kadu, DFDO Pasighat to submit a representation to any of the appropriate authority for disposal as per guidelines and norms of government within 5 (five) days;

And whereas, in pursuance of the impugned government order No.Fish/E(TP)458 dated 5<sup>th</sup> Oct'215, Shri Obuk Mize, DFDO, Pangin, joined the establishment of Deputy Commissioner East Siang, Pasighat on 08/10/2015 to take over the additional charges of DFDO Pasighat:

And whereas, Shri Obuk Mize, DFDO Pangin took over the additional charges of the DFDO, Pasighat ex parte on 19/10/2015 while Shri Marngu Kadu, DFDO was yet to return from casual leave as sanctioned by Deputy Commissioner, Pasighat;

And whereas, in compliance with the order dated 16/10/2015 of the hon'ble High Court, Shri Marngu Kadu, DFDO submitted his representation dated 17/10/2015 in the office of the Commissioner (Fisheries) while the regular Commissioner (Fisheries) was out of station away in Bihar on election duty deployed by the Election Commission of India as General Observer, 212 Dehri AC;

And whereas, the Link Officer did not take action to dispose of the representation.

And whereas, on expiry of the 5 days stipulated time of disposal of the representation, Shri Marngu Kadu filed a contempt petition No.34(AP)2015 before the hon'ble Court for non disposal of the representation and violation of the order of the hon'ble court. The hon'ble court admitting the contempt petition passed order dated 06/11/2015 for initiation of contempt proceedings against the 3 contemnors, the regular Commissioner (Fisheries), Deputy Commissioner, Pasighat and Shri Obuk Mize, DFDO Pangin;

And whereas the regular Commissioner (Fisheries) resumed office on 16/11/2015 on completion of his assigned election duties on return from Bihar and having come to know about the WP No 470(AP)2015 and the subsequent orders of the hon'ble court took note of the representation dated 17/10/2015 of Shri Marngu Kadu.



And whereas the representation dated 17/10/2015 of Shri Marngu Kadu, DFDO was examined and submitted to the government for decision;




