TERMS AND CONDITIONS:

1. The appointment is purely on temporary basis and may be terminated at any time without assigning any reason and for further continuation of service is subject to satisfactory performance.
2. The appointees shall be on probation for a period of 2(two) years from the date of their joining and probation shall be regularized subject to satisfactory performance.
3. He or She shall strictly abide by all the Terms and conditions governing his/her appointment.
4. The appointment carries with it the liability to serve in any part of Arunachal Pradesh.
5. The other conditions of the services which are not specified herein will be governed by the relevant rules and orders as in force from time to time.
6. The service seniority will be categorizes and counted as per merit lists or recommendation of Board/APSSB and or the reserved ratio as prescribed under the Recruitment Rules.
7. If any declaration given or information furnished by him/her proves to be false or if He/She is found to have willfully suppressed any material or information He or She shall be liable for removal from service and such other action as government deems fit and proper.
8. He/She must follow good conduct and appropriate behavior at all times.
9. No TA/DA will be allowed while joining for first time appointment.
10. He/She should produce 2 (two) recent Pass port size photograph/Photo copy of Aadhar Card/Certificate of Age proof/Educational qualification/Certificate of fitness from the competent Medical Authority and 2 (two) Character Certificate from two Gazetted Officers at the time of joining.
11. Taking an Oath of Allegiance/Faithfulness to Constitution of India or making of a solemn affirmation to that effect in the prescribed form on joining.
12. Production of Release Order/NOC from the previous employer (applicable in the cases of person who are already in Government service).
13. He/She should report for duty and submit joining report at respective posting place within 30

(Thirty) days period from the date of issue of this appointment order, failing which it will be presumed that he/she is not willing to join government service and accordingly his/her appointment order shall be automatically stands cancelled.
