Further this sanction order is issued subject to adherence/compliance of the following stipulations:

- The expenditure during CFY 2019-20 is restricted to <u>Rs. 75,37,500.00 lakh (Rupees Seventy Five Lakh Thirty Seven Thousand Five Hundred) only being 50% release as per RE-2019-20</u> under the concerned Head of Account strictly.
- 2. District wise physical & financial target as communicated vide order no. FISH/DEV/BA(MNKA)-373/2019-20 Dtd. 19/12/2019 against each component remains the same and payment to the individual beneficiary component wise shall be restricted to 50% of the total unit cost during this CFY 2019-20.
- 3. The finance concurrence is subject to availability of fund during the financial year 2019-20 and the actual expenditure sanction should not exceed the amount of fund allocated against this project under RE-2019-20.
- 4. Department shall ensure the availability of land in case any dispute/litigation of land, responsibility shall be held on officer who signed the LAC.
- 5. The fund under Centrally Sponsored Scheme[(CSS) and State Share related to (CSS)] shall be placed/ transferred through PFMS Platform mode only.
- 6. The Contingency charges shall be restricted to 1.5% for the cost upto Rs. 3.00 Crore and the maximum rate of 1% of contingency charges to the project (s) at an estimated cost above Rs. 3.00 Crore and scheduled of rate shall be APSR 2018 as per Govt. order No. Fin [D]-04/2018 Dated 20th Nov.2018 and No. Fin [D]-6/2003 Dated 27th Sept'2018.
- 7. The DDO of the Department should ensure to obtain the copy of GST return 3 B filed for the previous Tax period from the Supplier/Contractor before releasing any payment as per Govt. order no. GST/27/2017 Pt. Dated 30th Oct'2018.

- The project should be completed as per original scope and specification and no revision of the estimate shall be entertained. There should be no time and cost over-run.
- 9. The fund should be utilized within specified time and strictly for the purpose for which it is sanction No. diversion of fund is allowed.
- 10. The concurrence is subject to non duplication with any other scheme. For any deviation, responsibilities shall be fixed on the concerned officer of the Department.
- 11. The GST/Royalty/Labour Cess wherever applicable as per prevailing rates which shall be deducted and deposit into Government account properly.
- 12. All codal formalities, the provisions and conditions prescribed in the GFR, DFPR and CPWD Manual etc. all the financial rules and regulations, the guidelines and directives issued by the Govt. of India, Ministry of Finance, GOI, Administrative Ministry of GOI, CVC and Govt. of Arunachal Pradesh in this regard from time to time should be followed in the letter and spirit without fail and any lapse in this regard shall squarely be responsibility of the Department.
- 13. The concurrence is also subject to following of codal formalities and ensuring guidelines of State Government/ Govt. of India which shall squarely be responsibility of the Department.
- 14. The execution of works/ schemes/ projects and procurements of items/materials/furniture etc should be done strictly as per the provisions of GFR, DFPR and CPWD Manual etc. All the financial Rules and Regulations, the guidelines and directives issued by Govt. of India, Ministry of Finance, GoI/Administrative Ministry of GoI, CVC and Govt. of Arunachal Pradesh in this regard from time to time should be followed in letter and spirit without fail. The process of tendering and competitive bidding should mandatorily be followed and complied with as envisaged in the GFR, DFPR, Finance Rules and Regulations and the conditions, guidelines, Circulars and directives issued/prescribed by Govt. of India, CVC and Govt. of Arunachal Pradesh in this regard.
- 15.All the condition and guidelines prescribed and specified by Ministry of DONER/NEC/Name of Administrative Ministry, Govt. of India/State Planning Department [as the case may be] shall be followed in letter and spirit without fail.
- 16. Department shall ensure to Geo Tag for the work and enter in MIS Office the asset is created and forward a copy of the same to FD and Planning, in case of Beneficiary Oriented Schemes/Project (Wherever applicable)
- 17. Department shall ensure to Procure/Purchase of Goods and Services through Government e-market (GeM) as per Notification vide No. FIN/E-II/30/2017 Dated 11th Oct'2017 (Wherever applicable)
- 18. The Expenditure is dubitable under Major Head of Account "4405-00-800(04)-08-00-53 (MW) (BA/SDS)" Code No. 04 Demand No. 43 (Plan)
